STORAGE FACILITY HOLD HARMLESS AGREEMENT AND NOTICE OF
LIABILITY WAIVER**

IN CONSIDERATION (OR EXCHANGE) FOR BEING PERMITTED TO UTILIZE THE REDSTONE ARSENAL STORAGE FACILITY, I HEREBY RELEASE THE REDSTONE ARSENAL DIRECTORATE OF MORALE, WELFARE AND RECREATION (DMWR) AND THE US GOVERNMENT FROM ANY LIABILITY OR CLAIMS, WHICH RESULT FROM THEFT OR VANDALISM DURING MY USE OF THE STORAGE FACILITY. I AGREE THAT I WILL NEVER PROSECUTE OR IN ANY WAY AID IN PROSECUTING ANY DEMAND, CLAIM OR SUIT AGAINST DMWR OR THE US GOVERNMENT FOR ANY LOSS OR DAMAGE TO MY PROPERTY THAT MAY OCCUR AS A RESULT OF THEFT OR VANDALISM DURING MY USE OF THE SPACE(S) FOR RV/BOAT STORAGE.

I RECOGNIZE THAT THERE IS A RISK OF THEFT OR VANDALISM IN THIS AREA AND THAT I WILL NEED TO MAINTAIN APPROPRIATE INSURANCE COVERAGE ON MY STORES VEHICLE (AND ITS CONTENTS) IN ORDER TO PROTECT MYSELF AGAINST RISK. OTHERWISE, I WILL SELF-INSURE AGAINST ANY LOSS DUE TO THEFT OR VANDALISM AND ASSURE THE RISKS INVOLVED.

I ALSO UNDERSTAND AND AGREE THAT I MAY BE HELD LIABLE FOR ANY DAMAGE OR LOSS TO DMWR OR THE US GOVERNMENT THAT IS CAUSED BY YOUR NEGLIGENCE, WILLFUL MISCONDUCT OR FRAUD.
